### **Naming ODBFP in your Will or Estate Plans**

#### **Minimum Amount: Any Size**

Gifts of any amount may be given to ODBFP to be utilized at their discretion in support of mission-driven activities, including but not limited to purchasing food, building or leasing a space for a new location, and securing our mission to wipe out hunger in Collier County.

### **Bequest Options**

To make a bequest, you should speak with your attorney or estate planner to determine which type of bequest is best for you.

A bequest can be made in several ways:

1. You can gift a specific dollar amount or asset
2. You can gift a percentage of your estate
3. You can gift from the balance or residue of your estate.
4. You can make a beneficiary designation of certain assets

In addition, you may choose to keep your bequest open to supporting the mission of ODBFP, or you may wish to restrict it for specific use.

### **Restricted Bequests**

We recommend that you discuss your intentions regarding restricted bequests with ODBFP to ensure that your wishes can be met.

### **Naming ODBFP as a recipient of IRAs, Annuities & Trusts**

ODBFP may also be named as the recipient for IRAs, Charitable Gift Annuities, and various Charitable Giving Trusts (CLAT, CRAT, CRUT). Please consult your estate planner or attorney to understand your options better.

### **Gifts of Real Estate**

Want to make a gift to ODBFP without touching your bank account? Consider gifting real estate, such as a personal residence, vacation home, farm, commercial property or undeveloped land. Such a generous gift helps us continue our work to end hunger for as long as needed.

A gift of real estate also helps you. When you give ODBFP appreciated property you have held longer than one year, you qualify for a federal income tax charitable deduction. You may minimize or eliminate capital gains tax. And you no longer have to handle that property's maintenance costs, property taxes, or insurance. Another benefit: You don't have to deal with selling real estate. You can deed the property directly to ODBFP or ask your attorney to add a few sentences in your will or trust agreement.
